A RESOLUTION PERTAINING TO THE MUNICIPAL WATER POLLUTION PREVENTION ENVIRONMENTAL AUDIT REPORT (APRIL 2013 – MARCH 2014)

WHEREAS, The Town Of Gueydan's Louisiana Water Discharge Permit requires th an annual environmental audit report be prepared for the Town's wastewater treatment and collection system; and

WHEREAS, the Municipal Water Pollution Environmental Audt Report for the period from April 2013 to March 2014 has been completed; and

WHEREAS, the Mayor and Board of Aldermen have reviewed the Municipal Water Pollution Envriental Audit Report which is attached to this resolution; and

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Board of Aldermen of the Town of Gueydan to set forth the following actions necessary to maintain the permit requirements contained in the Louisiana Water Discharge Permit (LPDES) number LA0049883.

1. Continue to perform routine maintenance nd reparis throughout the collection and treatment system to stay within compliance of the LPDES Permit requirements.
