## ORDINANCE NUMBER

AN ORDINANCE AMENDING SUB-CHAPTER 25B, SECTION 25:21 OF THE CODE OF ORDINANCES OF THE TOWN OF GUEYDAN, LOUISIANA, ENTITLED "WATER RATES" IS HEREBY AMENDED TO READ AS FOLLOWS:

SECTION 1: BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE
TOWN OF GUEYDAN, LOUISIANA, in regular session convened on this day of
, 2021 that the provisions of Sub-Chapter 25B, Section 25:21 of the Code of Ordinances
of the Town of Gueydan entitled "Water Rates" is hereby amended to read as follows:

A. The monthly rate for the use of the Town of Gueydan's water system shall be charged to and collected in the amounts and from the classes and special users of the water system as follows:
