Motion by JOHN LASETER, seconded by LAUREL PORTIE' and carried to amend the agenda to include Police Chief Cru Delcambre. Chief Delcambre recommended to rescind the hiring of Jason Viator as a patrolman with the Gueydan Police Department.

Chief Delcambre recommended the acceptance of the provisional hiring of Zachary Guidry to be made to be a full-time position.
