

Minutes of the proceedings of the Mayor and Board of Aldermen of the Town of Gueydan, Louisiana, taken at regular meeting held Tuesday, October 4, 2016, at 6:00 o'clock P.M.

The Mayor and Board of Aldermen of the Town of Gueydan, Louisiana met in regular session with Mayor Chris Theriot presiding and the following Aldermen present:

Motion was made by SCOTT VALLO, seconded by GALE SMITH, and carried, that in as much as each member of the Board of Aldermen received a copy of minutes taken at Regular Meeting of September 6, 2016, that the reading of said minutes be dispensed with and same be adopted as written.

Motion by SCOTT VALLO, seconded by GALE SMITH and carried to approve the billing adjustments for September, 2016 in the amount of \$409.08 for penalty adjustments in which had postmark on or before the 15th of the month.

Fire Chief Evans Bourque had nothing to present at this meeting.

Police Chief Kayla Henry addressed the Governing Authority on the issue of the full time officer, also being the Resource Officer which reimbursement has been through the Vermilion Parish School Board. The Vermilion Parish School Board has abolished the position of a Resource Officer for Gueydan and the budget does not reflect paying said officer. Therefore, Chief Henry is requesting that budget amendment be approved for the full time officer pay. Motion by SCOTT VALLO seconded by GALE SMITH and carried that the Town of Gueydan absorb the payment for the School Resource Officer, which is to reflect said employee as a full time officer with the Gueydan Police Department.

There being no further business to come before the meeting thereupon motion SCOTT VALLO, seconded by GALE SMITH and carried the meeting thereupon adjourned at 6:28 o'clock P.M. on this 4TH day of October, 2016.
