

Minutes of the proceedings of the Mayor and Board of Aldermen of the Town of Gueydan, Louisiana, taken at regular meeting held Tuesday, January 3, 2017, at 6:00 o'clock P.M.

The Mayor and Board of Aldermen of the Town of Gueydan, Louisiana met in regular session with Mayor Chris Theriot presiding and the following Aldermen present:

Public Comment (3 minutes per person per agenda item)

Motion was made by GALE SMITH, seconded by JASON SUIRE, and carried, that in as much as each member of the Board of Aldermen received a copy of minutes taken at Regular Meeting of December 6, 2016, that the reading of said minutes be dispensed with and same be adopted as written.

Motion by CLAUDETTE PRICE, seconded by JASON SUIRE, and carried, that the reports of the Bookkeeper and Tax Collector be approved as filed.

Motion by JASON SUIRE, seconded by CLAUDETTE PRICE, and carried that the following transfer, on the date, and amount from fund is hereby ratified and approved:

Motion by Jason Suire, seconded by CLAUDETTE PRICE and carried to accept the billing adjustments in the amount of \$414.72 with \$99.60 being an adjustment for an overreading and \$315.12 for penalty due to payments being received after the 15th with a postmark on or before the 15th of the month.

Mayor Chris Theriot informed the Governing Authority that he had received an email from Larry Cramer, with Sellers & Associates with the requested proposal to have streets within the city limits reconstructed. The email an estimated cost of \$175, 728.30. Motion by GALE SMITH, seconded by JASON SUIRE and carried to accept the proposal submitted by Sellers & Associates in the amount of \$175,728.30. This project is a piggy back with the Vermilion Parish Police Jury so no bidding was needed.

Ms. Rebecca Broussard, Director of the Vermilion Parish Office of Emergency Preparedness, presented the Louisiana Unified Shelter Plan for Vermilion Parish, and gave a briefing of the changes made to the plan. Motion by JASON SUIRE, seconded by GALE SMITH and carried to adopt and accept the Louisiana Unified Shelter Plan for Vermilion Parish.

Fire Chief Evans Bourque presented the 2017 Roster of Volunteers for the Gueydan Volunteer Fire Dept. Police Chief Kayla Henry recommended Cru Delcambre as a part time patrolman with the Gueydan Police Department. Motion by JASON SUIRE, seconded by CLAUDETTE PRICE and carried to accept the recommendation of Cru Delcambre as a part time patrolman of the Gueydan Police Department.
