

Minutes of the proceedings of the Mayor and Board of Aldermen of the Town of Gueydan, Louisiana, taken at regular meeting held Tuesday, April 4, 2017 at 6:00 o'clock P.M.

The Mayor and Board of Aldermen of the Town of Gueydan, Louisiana met in regular session with Mayor Chris Theriot presiding and the following Aldermen present:

Motion was made by JASON SUIRE, seconded by CLAUDETTE PRICE, and carried, that in as much as each member of the Board of Aldermen received a copy of minutes taken at Regular Meeting of March 7, 2017, and Special Meeting of March 27, 2017, that the reading of said minutes be dispensed with and same be adopted as written.

Motion by JASON SUIRE, seconded by CLAUDETTE PRICE, and carried, that the reports of the Bookkeeper and Tax Collector be approved as filed.

Motion by CLAUDETTE PRICE, seconded by MARILYN CAMPBELL, and carried that the following transfer, on the date, and amount from fund is hereby ratified and approved:

Motion by GALE SMITH, seconded by JASON SUIRE and carried to accept the \$981.23 billing adjustments made in the month of March 2017.

Mayor Chris Theriot informed the Governing Authority that he had attended a meeting with Sellers & Associates and the Vermilion Parish Police Jury and stated that there are monies left over from the Rita and Gustave Hurricanes and that the Town will be applying for monies to be used for mitigation.

The Gueydan Recreation Sports Inc., has provided documentation that the organization is a 501(C)(3) and with the recommendation by Mayor Chris Theriot, the funds from the Youth Recreation Account be transferred to the Gueydan Recreation Sports Inc. Motion by JASON SUIRE, seconded by CLAUDETTE PRICE and carried to accept the recommendation by Mayor Theriot and transfer the funds to the Gueydan Recreation Sports Inc., from the Youth Recreation Account which funds were received the Hotel/Motel Tax.

Motion by JASON SUIRE, seconded by GALE SMITH and carried to declare as surplus the 2003 Ford Pickup (Bucket Truck) vin number ending in (8637). Minimum bid is \$20,000.00. Sealed bids will be received until 4:00 p.m. on the 6th of June, 2017 which bids will be opened at the Regular meeting held on June 6, 2017, at which meeting begins at 6:00 o'clock. p.m.

Motion by GALE SMITH, seconded by CLAUDETTE PRICE and carried to declare as surplus a 2002 Ford Pickup (vin number ending in 9426). Sealed bids will be received until 4 p.m. on the 6th day of June, 2017 which bids will be opened at the regular meeting held on June 6, 2017, at which meeting begins at 6:00 o'clock p.m.
