Mayor Jude Reese presented the Intergovernmental Agreement to the Board of Aldermen and explained that the Vermilion Parish Sheriff Department has surplus equipment namely bulletproof vests and is willing to donate said equipment to the Gueydan Police Department.

The following resolution was offered by JOHN LASETER seconded by SCOTT VALLO:

WHEREAS, the SHERIFF is the owner of a number of bulletproof vests described as having been manufactured by Safari Land, known as the Summit Model, Level 3A, which he does by these presents declare as surplus property of the Vermilion Parish Sheriff’s Department;

WHEREAS, the TOWN has a need for the afore described equipment to perform a public function;

WHEREAS, the SHERIFF, as chief law enforcement officer in and for the Parish of Vermilion, State of Louisiana, acknowledges the necessity of the above described equipment in the TOWN’s Police Department for the effective administration of laws enforcement therein;

WHEREAS, the TOWN does hereby acknowledge that the vest is at least five years old, that it is being accepted in an “as is” condition, and that they hold the SHERIFF harmless if the vest is defective in any way.

NOW, THEREFORE, the SHERIFF and TOWN agree to enter into a intergovernmental agreement. Wherein the SHERIFF agrees to and does by these presence donate and transfer unto the TOWN all of the rights,

titles and interests that the Vermilion Parish Sheriff's Department has in and to the afore described equipment. Said donation is gratefully accepted by the said Mayor of Gueydan.
