AN ORDINANCE ADOPTING AN AMENDED  
OPERATING BUDGET OF REVENUE AND  
EXPENDITURES FOR THE YEAR BEGINNING  
JANUARY 1, 2020 AND ENDING DECEMBER 31, 2020

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF GUEYDAN, LOUISIANA, met in Regular Session at its regular meeting place in Town Hall Meeting Room on this 22<sup>ND</sup> day of December 2020, that:

SECTION I: The attached amended estimates of Revenues and Expenditures for the fiscal year beginning January 1, 2020 and ending December 31, 2020, be and the same is hereby adopted to serve as an Operating Budget of Revenues for the Town of Gueydan, during the same period.

SECTION II: The attached amended estimates of Expenditures by departments for the fiscal year beginning January 1, 2020 and ending December 31, 2020, be and the same is hereby adopted to serve as an Operating Budget of Expenditures for the Town of Gueydan during the same period.

SECTION III: The adoption of this Operating Budget of Expenditures be and the same is hereby declared to operate as an appropriation of the amount therein set forth within the terms of the budget classification.

SECTION IV: Amounts are available for expenditures only to the extent included with the 2020 budget document as the estimated amounts.

Notice of introduction of this Ordinance, required by law was published on December 10, 2020.
